*TRANSFER \$100,004.40 FROM THE PARK BOARD CHECKING ACCOUNT TO THE GENERAL CHECKING ACCOUNT. THIS TRANSFER IS GENERAL FUNDS THAT WAS USED FOR THE DRA GRANT WHICH HAS BEEN CLOSED OUT AS OF SEPTEMBER 2021. THE CFO HAD TRANSFERRED THE \$ 100,004.40 TO THE PARK BOARD CHECKING ACCOUNT, BUT TO KEEP THE CONFUSION DOWN ON THE PARK BOARD FUNDS AND THE FUNDS TO BE USED FOR THE PARK GRANT, THE CFO IS TRANSFERING THE \$ 100,004.40 BACK TO THE GENERAL CHECKING WHICH IS WHERE THE FUNDS WERE ORIGINALLY TRANSFERRED FROM. THESE TRANSACTIONS WILL ALSO NEED TO BE MADE AS BUDGET AMENDMENTS TO THE FISCAL YEAR 2021-2022 BUDGET. THE VOTE THERE ON AS FOLLOWS.*

MS. HOLLAND INTRODUCED HERSELF AND THE GUEST THAT WERE WITH HER. MS. HOLLAND IS ASKING FOR THE SUPPORT OF THE MAYOR AND THE COUNCIL FOR THE CLEAN SWEEP MINISTRIES, TO HOUSE WOMEN AS A SAFE HOUSE FROM DRUG ADDICTION, HUMAN TRAFFICING AND ABUSE. MS. HOLLAND IS WANTING TO MEET WITH LAW ENFORCEMENT AND SOME OF THE CHURCHES AND THE COUNTY COMMISSIONERS, JUDGE, AND THE PROSECUTING ATTORNEY, SO THEY ALL CAN BE ON THE SAME PAGE.

MAYOR JOSEPH BLOUNT GAVE MS. HOLLAND AND THE CLEAN SWEEP MINISTRIES, HIS AND THE COUNCIL'S FULL SUPPORT ON EVERYTHING THAT THEY ARE WANTING TO DO AND IF THERE IS ANYTHING THAT THE CITY CAN HELP WITH THE PROCESS.

ALDERWOMAN MARY PAT WEST INTRODUCED DEBBY BUST OF THE COMMUNITY PARTNERSHIP TO MS. HOLLAND AND TOLD HER

THAT MS. BUST WOULD ALSO BE A GOOD RESOURCE FOR THEM ALSO.

MAYOR JOSEPH BLOUNT IS EXCITED FOR THE CLEAN SLATE MINISTRIES TO BE ABLE TO OFFER THIS PROGRAM TO THE PEOPLE OF THE CITY OF POTOSI.

**PLAYGROUND GRANT DEBBY BUST**

MS. BUST INFORMED THE COUNCIL THAT THEY HAVE RECEIVED THE GRANT FOR \$250,000.00 FOR THE CITY PARK. THE PARK BOARD WILL BE NOTIFIED CHRIS RICHARDS, JAMES COMPTON DEBBY BUST, JULIE HUFF, AND ROCKY BOYER AND THERE NEEDS TO BE TWO MORE APPOINTED. ALDERWOMAN MARY PAT WEST MADE A SUGGESTION OF HAVING A SPECIAL MEETING TO APPOINT THE PARK BOARD SO THEY CAN GET MOVING ON THE FUND RAISING. ALSO, THE ENGINEERS NEED TO BE MET WITH AT THE SPECIAL MEETING TO GET THE BID PACKAGES READY FOR ADVERTISEMENT. MAYOR JOSEPH BLOUNT TOLD MS. BUST THAT ANDY KINCAID WAS ANOTHER PERSON FOR THE PARK BOARD. WILL BE DOING SOME CALLING AROUND TO SEE ABOUT GETTING A COUPLE MORE ON THE PARK BOARD AND HAVE A SPECIAL MEETING TO APPOINT THEM EITHER THIS WEEK OR THE MIDDLE OF NEXT WEEK.

MS. BUST STATED THEY HAD APPLIED FOR ANOTHER GRANT FOR \$ 50,000.00 ON THE CUSHIONING FOR THE PLAYGROUND BUT THE POTOSI R-3 SCHOOL RECEIVED THAT GRANT.

MS. BUST SAID THAT THERE WILL BE CORPORATE DONATIONS, AND SOME FUND-RAISING EVENTS TO RAISE MONEY FOR THE CITY PARK GRANT.

ALDERWOMAN MARY PAT WEST HAS CONCERNS THAT THE MATERIALS THAT WERE BID ON BACK IN 2020 THE CITY WILL HAVE

TO GET OTHER BID BECAUSE EVERYTHING WILL BE HIGHER NOW BECAUSE OF COVID-19. THE BID PACKAGES NEED TO BE SENT OUT SO THE CITY OF POTOSI AND THE COMMUNITY PARTNERSHIP KNOWS HOW MUCH MONEY THAT NEEDS TO BE RAISED.

MAYOR JOSEPH BLOUNT STATED WE NEED TO START BUILDING THE PAVILLION, A LOT OF PEOPLE USE IT FOR REUNIONS AND BOOK IT YEARS IN ADVANCE.

MS. BUST REMINDED, THE COUNCIL SINCE 1973 WHEN MAYOR DONNIE BARTON WAS IN OFFICE, THEY SIGNED AN ORDINANCE SAYING THE PARK COULD NEVER BE SOLD IT WILL ALWAYS HAVE TO BE USED AS PUBLIC RECREATIONAL PROPERTY.

MAYOR JOSEPH BLOUNT SAID HE APPRIECIATED ALL THE HARD WORK MS. BUST HAS DONE TO GET THIS GRANT AND THAT THERE IS STILL A LOT OF WORK STILL TO BE DONE. THIS HAS BEEN A LONG PROCESS.

**JERRY SANSEGRAW-BECKY HOWELL**

MR. SANSEGRAW HAS ANOTHER MEETING THAT HE NEEDED TO ATTEND. MS. HOWELL IS REPRESTINT SEVERAL DIFFERENT GROUPS. MS. HOWELL LIVES ACROSS THE STREET FROM HERITAGE PARK AND NEXT TO SINCLAIR FLORIST, THERE IS A PAVILLION IN THE PARK ACROSS THE STREET. MS. HOWELL HELP RAISE THE MONEY FOR THE PARK AND IT HAS ALWAYS BEEN THE PERFECT PLACE TO GET PICTURES MADE, TO HAVE BIRTHDAY PARTIES, AND OTHER FAMILY GATHERINGS, BUT RECENTLY THE HOMELESS ARE USING IT TO SPEND THE NIGHT IN THE PARK. THE HOMELESS ARE DOING SOME THINGS THAT IS NOT GOOD FOR THE CITY. DRUGS, BAD LANGUAGE, AND THEY ARE STARTING FIRES AT THE PARK. MS. HOWELL HAS

WORRIES ON WHAT SHE HAS SEEN OVER THE PAST YEAR. SHE IS CONCERNED FOR THE NEIGHBORHOOD. THE PARK BEING RUN OVER WITH THE HOMELESS. THE HOMELESS ARE SLEEPING AT THE PAVILLION AND THERE HAS BEEN DRUG NEEDLES HAVE BEEN FOUND ON THE GROUNDS.

MS. HOWELL HAS COMMENDED THE POTOSI POLICE DEPARTMENT FOR THEIR EFFORTS IN TRYING TO HELP WITH THE SITUATION, CHIEF MIKE GUM SUGGESTED TO JERRY SANSEGRAW TO PUT SIGNS UP POSTING THE HOURS OF THE PARK AND IF ANYONE HAS TO CALL THE POLICE DEPARTMENT THEY WILL COME AND GIVE THEM AN ORDER TO LEAVE IF THEY DISOBEY AND COME BACK, THEY WILL BE ARRESTED. MAYOR JOSEPH BLOUNT TOLD MS. HOWELL THAT THEY WOULD PATROL AS MUCH AS THEY CAN IN THE AREA.

MS. DEBBY BUST SAID ONE OF THE CHURCHES GOING TO OPEN UP THEIR SHOWERS FOR THE HOMELESS TWO DAYS A WEEK. MS. BUST SAID SHE COULD PUT UP PAVILLIONS ON HER PROPERTY. SHE KNOWS A LOT OF THE KIDS THAT ARE HOMELESS. THERE IS A REAL NEED FOR A PROGRAM FOR THE HOMELESS.

MS. HOWELL APPRIECIATED THE COUNCIL LISTING TO HER CONCERNS.

THE MAYOR SAID THAT ROB FROM ARCHER ENGINEERING WILL BE WORKING ON THE SIDEWALK GRANT FOR 2022 JEFFERSON AND P HWY.

## **CHIEF OF POLICE REPORT**

CHIEF OF POLICE MIKE GUM GAVE HIS MONTHLY REPORT TO THE BOARD OF ALDERMAN AND ANSWERED ANY QUESTIONS THAT THE COUNCIL HAD IN REGARD TO THE REPORT.

CHIEF GUM EXPLAINED TO THE CITY COUNCIL THAT WHEN WE GET THE NEW RADIO'S THEY ARE REQUIRED TO HAVE A BACK UP SYSTEM ONCE THE POLICE DEPARTMENT GETS ON THE MOSHWIN THEY SHOULD BE GOOD.

CHIEF GUM GAVE A 911 UPDATE THEY ARE STILL AT A STAND STILL AND THEY DON'T HAVE THE FUNDS AVAILABLE. WASHINGTON COUNTY COMMISSIONERS ARE BEHIND THE MOTOROLA RADIO'S. CHIEF GUM THINKS WE COULD SELL OUR OLD RADIO'S THE FIRE DEPARTMENT OR CALEDONIA BECAUSE THEY WILL STILL WORK ON THE ANALOG SYSTEM. CHIEF GUM EXPLAINED THAT IT WILL PROBLEY BE ABOUT SIX MONTHS BEFORE THE RADIO'S COME IN THERE ARE ABOUT 10 COUNTIES THAT ARE AHEAD OF THE CITY OF POTOSI.

CHIEF GUM, THANKED STREET SUPERVISOR MARTIN LAWSON AND HIS CREW FOR HELPING OUT AND MOVING FURNITURE TO THE BASEMENT AT THE NEW BUILDING.

ALDERMAN ELMER AKERS TOLD CHIEF GUM THAT WE COULD GET A BID FROM THE GAS ENGINEER LINDSEY ENLOE FOR A BORE ACROSS THE ROAD OF 8 AND 21.

RANDY ELLIOTT SAID HE WOULD BUY THE BROWN JEEP AND WAIVE THE TOW BILL AND PAY \$200.00. THE COUNCIL AGREED ON THIS AT THE LAST MEETING.


